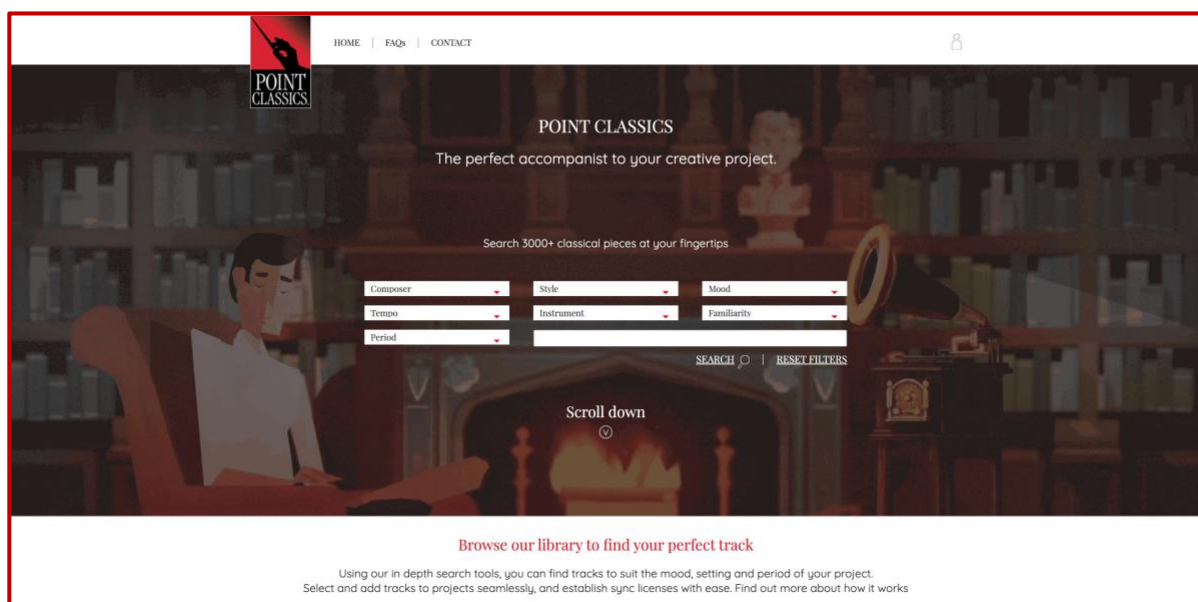

## IMPORTANT UPDATE: NEW REQUIREMENTS FOR INTERNATIONAL PAYMENTS

From **November 2026**, new payment regulations will apply to international **SEPA** and **SWIFT** transfers.

To help ensure your payments are processed without delay, please note the following:

**REQUIRED: TOWN/CITY AND COUNTRY**

Payments to Australia, Canada, Cuba, India and Turkey, and all payments made in **Canadian Dollars (CAD)**, must include the payee's town/city and country in the required format.

**OPTIONAL ADDRESS: ALL OTHER COUNTRIES AND CURRENCIES**

Providing the payee's address is optional. However, if you choose to include an address, all mandatory address fields must be completed.
